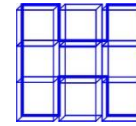
There is no remuneration provided, but Board Directors are personally rewarded through new knowledge, acquisition of new skills, and by the acknowledgement that they are making a valuable contribution to their community.

The Board needs at least three new Directors and is in particular need of at least one Director with financial literacy and at least one Director with an Indigenous background. Previous Board experience, knowledge of Ontario's health care system, and knowledge of Indigenous culture are also valuable assets to the Board. The Board is also seeking a Director with recent experience as a patient or caregiver of a patient at the hospital within the last two years.
